

Report of the Fourth Ordinary Meeting of the Lake Tanganyika Authority Conference of Ministers



26 November, 2010 Mulungushi International Conference Centre, Lusaka, Zambia

INTRODUCTION

- 1. The fourth ordinary meeting of the Lake Tanganyika Authority (LTA) Conference of Ministers took place on 26th November 2010 at Mulungushi International Conference Centre in Lusaka, Republic of Zambia.
- 2. Delegates from the four riparian countries were led by Honourable Jean-Marie NIBIRANTIJE, Minister of Water, Environment, Territory Management and Urban Planning of the Republic of Burundi, Honourable Norbert Basengezi KATINTIMA, Minister of Agriculture, Fisheries and Livestock of the Democratic Republic of Congo, Mrs. Ruth H. MOLLEL, Permanent Secretary, Vice-President's Office in charge of Environment of the United Republic of Tanzania and Honourable Catherine NAMUGALA, Minister of Tourism, Environment and Natural Resources of the Republic of Zambia.
- 3. Staff members from the LTA, United Nations Development Programme / Global Environment Facility (UNDP/GEF) Regional Project Coordination Office, National Coordination Units (NCUs) and UNDP/GEF Project Management Units (PMUs) attended the meeting as observers. Representatives of the following partner organizations: UNDP, the African Development Bank (ADB), Food and Agriculture Organization of the United Nations (FAO) and the International Union for the Conservation of Nature (IUCN) also attended the meeting as observers.
- 4. The Agenda and the list of delegates (and observers) are respectively included in Annexes 1 and 2 of the report.

Agenda Item 1: WELCOME AND OPENING REMARKS

- 5. The Opening Ceremony of the fourth ordinary meeting of the Conference of Ministers was graced by the presence of the Guest of Honour, Honourable Dr. Kalombo MWANSA, Minister of Defence of the Republic of Zambia.
- Before the official opening of the meeting, the LTA Executive Director called the meeting to order at 11:30 Hours and welcomed all the delegates and observers to the meeting. Thereafter, the Executive Director invited the Heads of Delegation to deliver their opening statements.

Remarks by Heads of Delegation

- 7. The first statement was made by Honourable Catherine NAMUGALA, Minister of Tourism, Environment and Natural Resources of the Republic of Zambia. In her statement shown under Annex 3, Honourable NAMUGALA welcomed all delegates to Zambia and urged everyone to feel at home. She went on to say that the meeting was very important to all the Lake Tanganyika riparian countries and hoped that there would be fruitful deliberations and outcomes.
- 8. The Burundian Head of Delegation, Honourable Jean Marie NIBIRANTIJE, Minister of Water, Environment, Territory Management and Urban Planning paid tribute to the Republic of Zambia for hosting the fourth ordinary meeting of the Conference of Ministers. He thanked the supporting partners and requested them to continue providing support to the Lake Tanganyika Authority. Honourable NIBIRANTIJE's statement is shown under Annex 4.

9. In her statement shown under Annex 5, the Tanzanian Head of Delegation, Mrs. Ruth H. MOLLEL, Permanent Secretary, Vice-President's Office in charge of Environment, thanked the Republic of Zambia for the hospitality and organizing the meeting in Lusaka. She stated that the meeting offered a very good opportunity to reflect on the decisions of the previous meetings and on the implementation status of the Convention on the Sustainable Management of Lake Tanganyika. Mrs. MOLLEL said that there was need to come up with workable mechanisms for financial sustainability of the LTA. The Tanzanian Head of Delegation suggested that Permanent Secretaries should be included in the LTA structure.

Statements from Supporting Partners

- 10. Mr. Jean-Louis KROMER made a statement on behalf of the ADB. In his statement shown under Annex 6, Mr. KROMER thanked the Government of the Republic of Zambia for hosting the meeting and for the excellent logistical arrangements. He was pleased to see that all the NCUs and the LTA had made some progress. However, he stated that there was need to improve the implementation of activities at the regional level. Furthermore, he called upon the riparian countries to ensure timely payment of national contributions which also served as counterpart funds for the ADB grant and loans. Mr. KROMER called for re-evaluation of the terms and conditions of the national contributions of the riparian countries to the LTA in order to ensure that they can be complied with on a sustainable basis.
- 11. Mrs. Viola MORGAN, the Country Director for UNDP Zambia Office, thanked the Zambian government for hosting the meeting which reaffirmed Zambia's commitment in furthering the sustainable management of Lake Tanganyika. She emphasized that improving the livelihoods of people living in the Lake Tanganyika Basin through sustainable development strategies was a goal that the UNDP strongly advocated and would therefore continue to support the implementation of the Strategic Action Programme and the Convention on the Sustainable Management of Lake Tanganyika. Mrs. MORGAN's statement is shown under Annex 7.
- 12. Mr. John JORGENSEN made a statement on behalf of the FAO. In his statement shown under Annex 8, Mr. JORGENSEN highlighted the economic importance of Lake Tanganyika and said that it was an enormously important source of food, income and livelihoods for millions of people not only in the four riparian countries that share the lake but in the entire East and Central African region. He further informed the meeting that FAO had for many years supported a number of activities especially in fisheries management on Lake Tanganyika. Mr. JORGENSEN said that FAO was ready and looking forward to working with the LTA through provision of technical assistance in the implementation of the ADB supported Project to Support the Lake Tanganyika Integrated Regional Development Programme (PRODAP).
- 13. Ms. Esther ABONYO made a statement on behalf of the IUCN. In her statement shown under Annex 9, Ms. ABONYO assured the meeting that IUCN was dedicated to working with the LTA and the riparian countries to lessen the threat of biological invasions to the biodiversity of Lake Tanganyika and its catchment. She further observed that there was need to involve the riparian local communities in order to achieve sustainability in activity implementation.
- 14. Dr. Charles KAHINDO made a statement on behalf of WWF. He thanked the Republic of Zambia for the hospitality and stated that WWF was honoured to be invited to the fourth ordinary meeting of the Conference of Ministers in Lusaka. Dr. KAHINDO informed the

meeting that WWF had been sub-contracted by the UNDP/GEF Project to implement the Project Component on catchment management in the Democratic Republic of Congo. In conclusion, Dr KAHINDO assured the delegates and observers that WWF would follow its main core values of results, integrity and respect to effectively implement the project in close collaboration with partners and local communities.

Remarks by the out-going Chairperson of the Conference of Ministers

- 15. The out-going Chairperson of the Conference of Ministers, Honourable Norbert Basengezi KATINTIMA, the Democratic Republic of Congo Minister of Agriculture, Fisheries and Livestock thanked the Government of Zambia for hosting the meeting. He also expressed appreciation to the partners for attending the meeting. Honourable KATINTIMA mentioned some successes achieved under his leadership including the approval of the Staff Rules and Conditions of Service of the LTA staff members, signing of the LTA Headquarters Agreement, approval of the LTA Rules of Procedures, approval of the LTA Financial Regulations and approval of the LTA logo and flag.
- 16. Honourable KATINTIMA further informed the meeting that he recognized the shortcomings with regard to timely remittance of national contributions by some riparian countries but he recognized the commendable efforts made by the United Republic of Tanzania in remitting full national contributions to the LTA Secretariat. Before calling upon the Guest of Honour to officially open the fourth ordinary meeting of the Conference of Ministers, Honourable KATINTIMA expressed hope that the fulfilment of national contribution obligations by all the riparian countries would improve during the tenure of the in-coming Chairperson. The full statement made by Honourable KATINTIMA is shown under Annex 10.

Agenda Item 2: OPENING REMARKS BY THE GUEST OF HONOUR

- 17. The Guest of Honour, Honourable Dr. Kalombo MWANSA, Minister of Defence of the Republic of Zambia, officially opened the fourth ordinary meeting of the Conference of Ministers. Honourable MWANSA welcomed all the delegates and observers to Zambia and informed the meeting that the Republic of Zambia felt honoured to host the meeting.
- 18. The Guest of Honour recognized the efforts made by the riparian countries in addressing the socio-economic and environmental challenges of the Lake Tanganyika and its Basin. He also thanked the cooperating partners for their financial and technical support. The Guest of Honour concluded his remarks by encouraging the delegates to continue with the same spirit of regional cooperation that had already been exhibited. The full text of Honourable MWANSA's statement is shown under Annex 11.

Agenda Item 3: CONSULTATIONS BETWEEN HEADS OF DELEGATION

19. After the Opening Ceremony, Heads of Delegation took a moment for consultations behind closed doors.

Agenda Item 4: Formal Hand-over of Chairmanship / Constitution of the Bureau

20. When the meeting resumed after consultations between Heads of Delegation, the LTA Executive Director introduced Agenda Item 4 and called upon the out-going Chairperson of the Conference of Ministers to officially handover the Chairmanship to Zambia. Honourable KATINTIMA expressed gratitude for the opportunity to have served as Chairman of the

Conference of Ministers and promised to give his support to the in-coming Chairperson: Honourable NAMUGALA, the Zambian Minister of Tourism, Environment and Natural Resources. In conclusion, Honourable KATINTIMA presented and handed over the LTA flag to Honourable NAMUGALA.

- 21. In her acceptance remarks, Honourable NAMUGALA stated that it was an honour for her to take up the important role of Chairperson of the Lake Tanganyika Conference of Ministers. She further mentioned that she would rely on the support and advice from Ministers in other riparian countries of Burundi, Democratic Republic of Congo and Tanzania. Honourable NAMUGALA went on to say that she would also rely on the advice of the technocrats in the four riparian countries. Finally, Honourable NAMUGALA called upon the supporting partners to continue their invaluable support for the sake of sustainable management of Lake Tanganyika and its Basin. Thereafter, Honourable NAMUGALA called the meeting to order and invited the riparian countries to nominate rapporteurs.
- 22. Tanzania and Burundi were invited to serve as Anglophone and Francophone Rapporteurs respectively. The two countries accepted the invitations.

Agenda Item 5: ADOPTION OF THE AGENDA

23. The Democratic Republic of Congo proposed adoption of the agenda and the proposal was seconded by the United Republic of Tanzania. The draft agenda was adopted with no amendments.

Agenda Item 6: Adoption of Minutes of the 3rd Ordinary Meeting

24. The Conference of Ministers unanimously adopted the minutes of the third ordinary meeting of the Conference of Ministers.

Agenda Item 7: MATTERS ARISING FROM THE 3RD ORDINARY MEETING

25. The LTA Executive Director presented a report on three items as matters arising from the third ordinary meeting as follow.

Zambia fulfilment of the ADB conditions (CoM/4/7.1)

26. The LTA Executive Director informed the Conference of Ministers that Zambia had fulfilled the ADB loan conditions by submitting the document on sustainable debt management to ADB and establishing the NCU office in Mpulungu. The first disbursement from ADB was received in February 2010.

The Conference of Ministers took note of progress and achievements made by the Republic of Zambia.

National Contributions (CoM/4/7.2)

27. The LTA Executive Director reminded the Conference of Ministers that at the third ordinary meeting, the riparian countries were called upon to expedite remittance of full national contributions to the LTA. He further presented the status of national contributions as of 31st October 2010.

28. The LTA Executive Director then suggested that the Conference of Ministers deal with the issue when considering the report of the fourth ordinary meeting of the Management Committee.

The Conference of Ministers agreed to discuss the remittance of national contributions to the LTA at the time of considering the report of the fourth ordinary meeting of the Management Committee.

Signing of the LTA Headquarters Agreement (CoM/4/7.3)

29. The LTA Executive Director reported that the LTA Headquarters Agreement with the Republic of Burundi was signed on 4th November, 2009. The LTA Executive Director, Dr. Henry MWIMA, signed on behalf of the LTA and the Minister of External Relations and International Cooperation, His Excellency Dr. Augustin NSANZE, signed on behalf of the Government of the Republic of Burundi.

The Conference of Ministers took note of the progress and achievements made by the LTA Secretariat and the Government of the Republic of Burundi.

Agenda Item 8: Consideration of the Report of the 4th Ordinary Meeting of the Management Committee

- 30. The LTA Executive Director reported that the fourth ordinary meeting of the Management Committee was held at the Mulungushi International Conference Centre in Lusaka, Zambia from 23rd to 25th November 2010. The Executive Director further reported that Dr. Julius NINGU from the United Republic of Tanzania formally handed over the Chairmanship to Dr. Harris PHIRI of the Republic of Zambia. With the permission of the Chairperson of the Conference of Ministers, the LTA Executive Director called upon Dr. PHIRI to present the report of the fourth ordinary meeting of the Management Committee.
- 31. Dr. Harris PHIRI presented a detailed report of the fourth ordinary meeting of the Management Committee and invited the Conference of Ministers to take note of the decisions made by the Management Committee as well as to consider and approve a number of decisions and recommendations.

Items for consideration, attention and approval by the Conference of Ministers

32. The Management Committee Chairman invited the Conference of Ministers to take note of the following decisions and recommendations made by the Management Committee:

Matters Arising from the third Ordinary Meeting

33. The Management Committee Chairman reported that the Management Committee took note of the progress and achievements made by LTA Secretariat in implementing the issues raised during the third ordinary meeting of the Management Committee. He specifically mentioned the following: Zambia's fulfilment of the ADB conditions, status of national contributions, and appointment of the LTA and NCU staff members.

The Conference of Ministers took note of progress and achievements made by the LTA Secretariat

LTA Secretariat Annual Report for 2009 and Progress Report for 2010

34. The Management Committee Chairman reported that the Management Committee took note of the LTA Annual Report for 2009, LTA Audited Accounts Report for 2009, the LTA Progress Report for 2010 and the UNDP/GEF Project Progress Report for 2010.

The Conference of Ministers took note of progress and achievements made by the LTA and the UNDP/GEF Project Coordination Office.

Lake Tanganyika Authority Annual Workplan and Budget for 2011

35. The Management Committee Chairman reported that the LTA Secretariat presented the Annual Workplan and Budget for 2011 to the Management Committee for approval. The Management Committee approved the Annual Workplan and Budget for 2011 but requested the LTA Secretariat to come up with a cost effective mechanism for the purchase of surveillance boats for riparian countries. Furthermore, the Management Committee advised that the recruitment of the Deputy Executive Director which had been planned for the first quarter of 2011 should be undertaken after the financial situation of the LTA had improved.

The Conference of Ministers took note and approved the LTA Secretariat Annual Workplan and Budget for 2011.

National Contributions to LTA

36. The Management Committee Chairman reported that the LTA Secretariat presented the report and a summary of the status of national contributions to LTA by the end of October, 2010 (details in the table below). As shown in the table, only the United Republic of Tanzania had fully remitted the national contributions. The Management Committee Chairman reported further that the Management Committee had recommended that all outstanding national contributions should be remitted to the LTA by the end of December 2010.

37. The Chairperson of the Conference of Ministers, Honourable NAMUGALA, informed the meeting that fulfilment of the national contributions was one of the biggest challenges faced by the riparian countries. She commended the United Republic of Tanzania for showing leadership and commitment by remitting full national contributions to the LTA. She further requested fellow Ministers to make bold decisions and indicate when the 2009 and 2010 outstanding national contributions would be paid.

In response to the Chairperson's request, Honourable KATINTIMA informed the meeting that the Democratic Republic of Congo would pay the outstanding contributions in \$150,000 instalments in the months of November 2010, February 2011, April 2011 and June 2011. Honourable NIBIRANTIJE stated that Burundi would pay the entire amount by the beginning of 2011. Honourable NAMUGALA said that the Government of the Republic of Zambia would pay the outstanding national contributions within the next five months starting from December 2010.

UNDP/GEF Regional Project Annual Workplan and Budget for 2011

38. The Management Committee Chairman reported that the Management Committee discussed and approved the UNDP/GEF Regional Project Annual Workplan and Budget for 2011 as presented. The Management Committee Chairman also reported that the UNDP/GEF Project on Lake Tanganyika Mid-Term Evaluation would be undertaken early next year.

The Conference of Ministers took note and endorsed the UNDP/GEF Regional Project Annual Workplan and Budget for 2011.

Fundraising Strategy (MC/4/8.1)

39. The Conference of Ministers was informed that the Management Committee discussed and adopted the LTA Fundraising Strategy. The Management Committee noted that the Fundraising Strategy should clearly articulate the funds for operational activities and for staff remuneration so that it would be easy to sell the strategy to donors.

The Conference of Ministers took note and approved the LTA Fundraising Strategy.

Regional Steering <u>Committee terms of reference</u>

40. The Management Committee Chairman reported that Management Committee discussed and approved the Regional Steering Committee terms of reference presented by LTA Secretariat.

The Conference of Ministers took note and endorsed the Regional Steering Committee terms of reference.

LTA Monitoring and Evaluation Framework

41. The Management Committee Chairman reported that the Management Committee discussed and approved the LTA Monitoring and Evaluation Manual.

The Conference of Ministers took note and endorsed the LTA Monitoring and Evaluation Manual.

<u>Declining water levels, deforestation and sedimentation</u>

42. The Conference of Ministers was informed that the LTA Secretariat presented a report to the Management Committee on declining water level. The key findings of the rapid assessment demonstrated that human activities such as destruction of a barrage in the Lukuga River did not have any significant influence on natural water level fluctuations in Lake Tanganyika over the period: 1995 - 2010. The Management Committee took note and agreed that more studies should be undertaken in order to generate quantitative information that would be useful for management decisions.

The Conference of Ministers took note and endorsed the decision by the Management Committee.

Notifications to Contracting States

43. The Management Committee Chairman reported that the Management Committee discussed the need for the four Contracting States of the Convention on the Sustainable Management of Lake Tanganyika to report regularly to the LTA in accordance with Articles 14, 20 and 22 of the Convention. After the discussion, the Management Committee recommended that each Contracting State should submit the reports requested in the two Notifications issued by the LTA Secretariat not later than the end of February 2011. Copies of the Notifications issued by the LTA Secretariat are shown under Annex 12.

The Conference of Ministers took note and endorsed the recommendation by the Management Committee.

Amendments to the present Convention

44. The Management Committee Chairman reported that Burundi volunteered to propose an amendment to the Convention to increase the number of Management Committee members from three to four to include one member from the Ministry in charge of Finance. After reviewing the provisions of Article 24 paragraph 6 of the Convention, the Management Committee concluded that it was not necessary to propose any amendment for inclusion of ADB on the list of Observers.

The Conference of Ministers took note and endorsed the decision by the Management Committee.

Roles of Permanent Secretaries on the LTA Structure

- 45. The Management Committee Chairman reported that the issue to include Permanent Secretaries on the LTA structure and to determine their roles arose from the extraordinary meeting held in Dar es Salaam, Tanzania on 12th May, 2010. The Conference of Ministers heard that during the Management Committee discussion, the Tanzanian and Zambian delegations supported the inclusion of Permanent Secretaries in the LTA structure while the Democratic Republic of Congo and Burundi did not support the suggestion.
- 46. The Management Committee Chairman further reported that the matter was brought to the Conference of Ministers for a definite decision because the riparian countries had not reached a common position at the Management Committee level.
- 47. The Tanzanian Head of Delegation said that Permanent Secretaries as controlling officers of funds in their respective ministries should be involved in supervising programme and project activity implementations and should ensure that there was proper accountability for the resources at both the regional and national levels.
- 48. The Burundian Head of Delegation informed the meeting that Burundi supported the inclusion of Permanent Secretaries in the LTA structure and stated that the Republic of Burundi had introduced the position of Permanent Secretaries in all the Ministries which was in line with the East African Community structures.
- 49. The Democratic Republic of Congo Head of Delegation said that he did not see the need for including Permanent Secretaries in the structure of the LTA.

After a long discussion, the Chairperson almost called for a vote on the matter, but the decision was rescinded to allow for a short recess in order for the riparian countries to consult. After the short recess, the Democratic Republic of Congo Head of Delegation stated that he had – after consultations - agreed to the suggestion of including the Permanent Secretaries on the LTA structure and supported the idea of determining their roles. Finally, the Conference of Ministers agreed to the proposal of determining the roles of Permanent Secretaries and to include them on the LTA structure

Formation of Technical Committees and Appointment of Official Contact Persons

- 50. The Management Committee Chairman reported that the LTA Secretariat proposed to the Management Committee the need to establish four technical committees, namely Socio-economic, Fisheries Management, Biological Diversity and Water Quality/Pollution Control, to assist in the performance of its functions in accordance with Article 27, paragraph 2 of the Convention. Each Contracting State was requested to submit nominations of one expert for each of the four technical committees.
- 51. The Management Committee Chairman also reported that the LTA Secretariat had requested each riparian country to formally communicate to the LTA Secretariat the name(s) of officially appointment Contact Person(s) in accordance with Rule 7 of the Rules of Procedures. Finally, the Management Committee Chairman reported that the Management Committee agreed that Contracting States should submit to the LTA Secretariat the names of experts to sit on each of the four technical committees and also submit the name(s) of official LTA Contact Person(s). The deadline for the submissions to the LTA Secretariat was 31st December 2010.

The Conference of Ministers took note and endorsed the decisions by the Management Committee.

LTA/FAO Technical Assistance Agreement for PRODAP

52. The Management Committee Chairman reported that the LTA/FAO Technical Assistance Agreement for PRODAP was signed on 10th September 2010 by Dr. Henry MWIMA, LTA Executive Director and His Excellency Mr. Arlindo P. BRAGANGA GOMES the FAO Resident Representative in Burundi at a brief ceremony held at the Ministry of External Relations and International Cooperation in Bujumbura, Burundi. His Excellency Dr. Augustin NSANZE, the Minister of External Relations and International Cooperation witnessed the signing and endorsed the Agreement on behalf of the Government of the Republic of Burundi. The signing ceremony was also witnessed and endorsed by His Excellency Ambassador Salomon BALIENE on behalf of the Government of the Democratic Republic of Congo and His Excellency Ambassador Dr. James NZAGI on behalf of the Government of the United Republic of Tanzania. On 11th November, 2010, the Agreement was endorsed by His Excellency Ambassador Darius BUBALA on behalf of the Government of the Republic of Zambia.

The Conference of Ministers took note and appreciated the efforts made by the LTA Secretariat, FAO and the four riparian governments.

Draft Updated Strategic Action Programme

53. The Management Committee Chairman reported that the LTA Secretariat presented a progress report on the process made in updating the Strategic Action Programme (SAP). The

Management Committee Chairman also reported that a roadmap for finalizing the SAP updating process and elaboration of the National Action Plans (NAPs) had been presented by the UNDP/GEF Project Regional Coordinator. After some discussion, the Management Committee recommended that the updating process of the SAP and elaboration of the NAPs should be completed in good time in order for the updated SAP to be presented at the next ordinary meeting of the Conference of Ministers for endorsement.

The Conference of Ministers took note of the efforts made in updating the SAP and endorsed the recommendation by the Management Committee.

National Coordination Units (NCUs) Staff Rules and Conditions of Service

54. The Management Committee Chairman reported that the Management Committee briefly discussed the draft Staff Rules and Conditions of Service for NCUs and called upon all the riparian countries to study the document and thereafter submit comments to the LTA Secretariat not later than 31st December, 2010. The Management Committee further resolved that if no comments were received by end of December 2010, the document would be considered approved. The Management Committee Chairman presented the decision of the Management Committee for approval by the Conference of Ministers.

The Conference of Ministers took note of the suggestions and approved the recommendation made by the Management Committee.

National Programme / Project Progress for 2010 and Activities Planned for 2011

55. The Management Committee Chairman reported that progress reports from January to September 2010 and highlights of activities planned for 2011 by NCUs and PMUs were presented by National Coordinators and Project Managers from Burundi, Democratic Republic of Congo, Tanzania and Zambia.

The Conference of Ministers took note of the progress and achievements in 2010 and also took note of the activities planned for 2011 by the NCUs and PMUs in the four riparian countries.

Programme/Project Coordination at National Levels

- 56. The Management Committee Chairman reported that all riparian countries had formally established National Steering Committees (NSCs) for the purpose of programme and project coordination at national levels. However, the Management Committee learned that the membership of NSCs did not (in the case of Burundi, Tanzania and Zambia) comply with the membership which the Conference of Ministers approved at the second ordinary meeting.
- 57. The Conference of Ministers was also informed that after a long discussion, the Management Committee noted that some countries had identified other important stakeholders like Agriculture that should be represented on the NSC and suggested that the NSC for each riparian country should be re-constituted with a minimum number of 8 and a maximum number of 12 members. Furthermore, the Management Committee observed that all the sectors identified in the decision of the second ordinary meeting of the Conference of Ministers should be represented. Finally, the Management Committee Chairman presented the decisions of the Management Committee to the Conference of Ministers for approval.

The Conference of Ministers took note and approved the decisions made by the Management Committee.

DATE AND VENUE FOR THE FIFTH ORDINARY MEETING

58. The Tanzanian Head of Delegation extended an offer for the United Republic of Tanzania to host the fifth ordinary meeting of the Lake Tanganyika Conference of Ministers in September 2011 at a date to be agreed upon after consultations between the host country and other riparian countries. The Heads of Delegation from Burundi, Democratic Republic of Congo and Zambia welcome the offer by the United Republic of Tanzania.

DECLARATION BY THE 4TH CONFERENCE OF MINISTERS

59. After a short recess, the delegates and observers reassembled and thereafter, Dr. Henry MWIMA, the LTA Executive Director read the Declaration of the fourth ordinary meeting of the Lake Tanganyika Conference of Ministers. The full text of the signed Declaration is shown under Annex 13.

ADOPTION OF THE REPORT OF THE 4TH CONFERENCE OF MINISTERS

60. Minutes of the fourth ordinary meeting of the Conference of Ministers will be adopted at the fifth ordinary meeting.

CLOSURE OF THE MEETING

- 61. In her closing remarks, the Chairperson of the Conference of Ministers, Honourable Catherine NAMUGALA thanked all the Heads of Delegation and observers for their useful contributions to the meeting. She also thanked all members of the Management Committee and representatives of supporting partners for their hard work as demonstrated by the report which was presented by the Management Committee Chairman. Finally, the Chairperson expressed very since thanks to all the riparian governments and supporting partners and called upon them to continue supporting the sustainable management of Lake Tanganyika and its Basin for the benefit of the riparian communities.
- 62. There being no other issues for discussion, the Chairperson officially closed the meeting at 17:10 Hrs and then invited all the delegates and observers to a dinner hosted by the host country at Fairview Hotel, Lusaka.

DISTINGUISHED DELEGATES;

REPRESENTATIVES OF THE DEVELOPMENT PARTNERS;

LADIES AND GENTLEMEN;

IT IS ON HONOUR AND PRIVILEGE FOR ME TO MAKE A STATEMENT AT THIS FOURTH SESSION OF THE CONFERENCE OF MINISTERS FOR THE LAKE TANGANYIKA AUTHORITY. ON BEHALF OF THE TANZANIAN DELEGATION, I'D LIKE TO EXPRESS MY GRATITUDE TO THE GOVERNMENT OF ZAMBIA FOR HOSTING THIS HISTORICAL MEETING AND THE HOSPITALITY EXTENDED TO US SINCE OUR ARRIVAL IN THIS BEAUTIFUL CITY OF LUSAKA.

I'D LIKE TO CONGRATULATE YOU, MR. CHAIRMAN, AND OTHER OFFICIALS OF THE BUREAU WHO HAVE BEEN ELECTED TO LEAD US IN OUR TODAY'S DELIBERATIONS. HON. CHAIRPERSON BE ASSURED OF OUR FULL CO-OPERATION AND I WISH YOU A SUCCESSFUL TENURE OF OFFICE. WE ARE EXTREMELY GRATEFUL TO LTA EXECUTIVE DIRECTOR AND HIS TEAM FOR THEIR COMMITMENT, DEDICATION, AND HARD WORK SHOWN SUPPORTING THE IMPLEMENTATION OF THE CONVENTION ON THE SUSTAINABLE MANAGEMENT OF LAKE TANGANYIKA.

HONOURABLE CHAIRPERSON,

THIS SESSION PRESENTS AN OPPORTUNITY OF REFLECTION ON THE IMPLEMENTATION STATUS OF THE CONVENTION ON THE SUSTAINABLE MANAGEMENT OF LAKE TANGANYIKA, AND OF ADVANCING ITS FUNDAMENTAL OBJECTIVES. ALLOW ME HON. CHAIRPERSON TO BRIEFLY HIGHLIGHT A FEW KEY ISSUES ON THE IMPORTANCE OF COLLECTIVE MANAGEMENT OF LAKE TANGANYIKA AND ITS BASIN.

FIRSTLY, LAKE TANGANYIKA IS A SHARED HERITAGE OF OUR RIPARIAN STATES AND HAS MANY ECONOMIC AND SOCIAL ACTIVITIES WHICH ARE CARRIED OUT WITHIN THE LAKE BASIN. THESE ACTIVITIES INCLUDE FISHING, AGRICULTURE, LIVESTOCK KEEPING, HUMAN SETTLEMENTS AND MINING, JUST TO MENTION A FEW. ALL THESE ACTIVITIES HAVE SOME BEARING ON THE SUSTAINABILITY OF THE LAKE RESOURCE.

HONOURABLE CHAIRPERSON,

IT IS, THEREFORE, IMPORTANT TO HAVE A SHARED RESPONSIBILITY AMONG US IN MANAGEMENT OF THIS LAKE WISELY. THIS SHOULD BE DONE WHILE BEARING IN MIND NOT ONLY THE VALUE, BUT ALSO THE FRAGILITY OF ITS ECOSYSTEMS.

HONOURABLE CHAIRPERSON AND DISTINGUISHED DELEGATES,

THE LAKE IS MORE THAN A FOOD BASKET FOR OUR COMMUNITIES. ITS BASIN IS HOME TO MORE THAN 10 MILLION PEOPLE. IT IS AN EXCELLENT AREA FOR UNITING THE FOUR RIPARIAN COUNTRIES. WE THEREFORE; HAVE A COMMON INTEREST IN THE CONSERVATION AND EQUITABLE UTILIZATION OF RESOURCES OF LAKE TANGANYIKA. IT IS, THUS OUR RESPONSIBILITY TO ENSURE THAT THE CHALLENGES FACING LAKE TANGANYIKA NAMELY DECLINING WATER LEVELS, POLLUTION FROM BOTH INDUSTRIAL AND DOMESTIC SOURCES, BIODIVERSITY LOSS, AND SEDIMENTATION ARE MINIMIZED AND FINALLY ELIMINATED.

DISTINGUISHED DELEGATES,

THIS CONFERENCE MARKS ANOTHER MILESTONE IN ASSESSING THE PROGRESS MADE TOWARDS SUSTAINABLE UTILIZATION OF THE RESOURCES AND IMPLEMENTATION OF PROJECTS UNDER THE REGIONAL PROGRAM. THE GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA NOTES THAT THERE ARE A NUMBER OF OBSTACLES THAT REDUCE THE PACE OF IMPLEMENTATION OF LAKE TANGANYIKA ACTIVITIES.

SOME OF THESE INCLUDE:

- (I) FINANCE: WE ALL KNOW THAT SUFFICIENT FUNDS ARE CRUCIAL FOR THE IMPLEMENTATION OF THE PLANNED ACTIVITIES. THEREFORE; THERE IS A NEED TO DEVELOP A MECHANISM THAT WILL ENSURE RESOURCE AVAILABILITY FOR A SMOOTH RUNNING OF THE CONVENTION. THIS CAN BE DONE THROUGH DEVELOPING A TRUST FUND TO BE BEEFED UP BY COLLECTION OF REVENUES AND TAXES FROM RESOURCES ACCRUED THROUGH FUND RAISING ENDEOVERS.
- (II) ORGANIZATIONAL STRUCTURE: THE CONVENTION HAS A CONFERENCE OF MINISTERS, THE MANAGEMENT COMMITTEE AND THE LTA SECRETARIAT. THERE IS NO PLATFORM FOR THE PERMANENT SECRETARIES WHO ARE WARRANT HOLDERS AND AT THE SAME TIME SUPPOSED TO ADVICE THE MINISTERS ON POLICY ISSUES AND THE EFFECTIVE MECHANISM OF IMPLEMENTING THE CONVENTION. SIMILARLY, AT REGIONAL LEVEL, THE PARALLEL STRUCTURE OF TWO COORDINATORS DOES NOT AUGUR WELL WITH GOOD GOVERNANCE. THEIR WORKING RELATIONSHIP DEPENDS ON GOOD WILL OF THE TWO PARTIES. A SYSTEM THAT GOES BEYOND THE GOOD WILL SHOULD BE ESTABLISHED. IT IS PROPOSED TO ENGAGE AN OVERALL CO-ORDINATOR WHO WILL BE ACCOUNTABLE FOR THE PERFORMANCE AND FINANCIAL ACCOUNTABILITY OF THE PROJECT.
- (III) NATIONAL CONTRIBUTIONS: TIME HAS COME WHEN WE SHOULD TIMELY AND FULLY CONTRIBUTE TO THE PROGRAMME SO AS TO ACHIEVE SUSTAINABLE DEVELOPMENT AND UTILIZATION OF THE NATURAL RESOURCES IN THE LAKE TANGANYIKA.

IT IS MY UNDERSTANDING THAT THESE ISSUES ARE AMONG TODAY'S AGENDA FOR OUR DELIBERATION. HON. MINISTERS, SUCCESSFUL IMPLEMENTATION OF THE CONVENTION IS IN OUR HANDS. THEREFORE; THIS IS AN OPPORTUNITY TO GIVE GUIDANCE TOWARDS THAT GOAL.

WE SINCERELY ACKNOWLEDGE AND APPRECIATE THE GENEROUS SUPPORT EXTENDED BY VARIOUS DEVELOPMENT PARTNERS, ESPECIALLY UNDP, GEF, THE AFRICAN DEVELOPMENT BANK (ADB), NORDIC DEVELOPMENT FUND (NDF), FAO AND IUCN FOR THEIR EFFORTS TOWARDS SUSTAINABLE MANAGEMENT OF THE LAKE TANGANYIKA. I ASSURE YOU OF TANZANIA'S COOPERATION FOR THE BEST OUTCOME.

DISTINGUISHED DELEGATES, LADIES AND GENTLEMEN,

LADIES AND GENTLEMEN,

FIRST, I WOULD LIKE TO THANK THE GOVERNMENT OF ZAMBIA FOR HOSTING THIS MEETING AND FOR THE EXCELLENT ORGANIZATION.

AS YOU KNOW, FOUR LOANS AGREEMENTS AND ONE GRANT HAVE BEEN SIGNED FOR THE FINANCING, BY THE AFRICAN DEVELOPMENT BANK, OF THE PROJECT TO SUPPORT THE LAKE TANGANYIKA INTEGRATED REGIONAL DEVELOPMENT PROGRAMME – PRODAP - FOR A TOTAL AMOUNT OF ABOUT 40 MILLIONS US DOLLARS.

IN THE LAKE TANGANYIKA BASIN, THE MAJOR NATURAL RESOURCES ARE INTENSELY EXPLOITED AND THE STRONG HUMAN PRESSURE CONSTITUTES A SERIOUS THREAT TO THE SUSTAINABILITY OF NATURAL RESOURCES AND SOCIAL CONDITIONS.

IN ORDER TO BETTER PROTECT THE LAKE ENVIRONMENT AND ENABLE THE SUSTAINABLE USE OF THE NATURAL RESOURCES, PRODAP AIMS AT RATIONALIZING THE EXPLOITATION OF FISHERIES RESOURCES, PROTECTING THE LAKE ENVIRONMENT IN A SUSTAINABLE MANNER AND, REDUCING THE POVERTY OF THE LAKE BASIN COMMUNITIES, WHO ARE AMONG THE POOREST IN THE REGION. FURTHER, IT AIMS TO DIVERSIFY SOURCES OF INCOME AND CREATE JOBS.

THE PROJECT REFLECTS THE PRIORITIES OF NEPAD, NOTABLY BY HIGHLIGHTING ECONOMIC COOPERATION AND REGIONAL INTEGRATION.

WE ARE VERY PLEASED TO SEE THAT THIS VERY IMPORTANT PROJECT IS FINALLY FULLY IMPLEMENTED. ALL NATIONAL COORDINATING UNITS ARE NOW IN PLACE, AS WELL AS THE LAKE TANGANYIKA AUTHORITY SECRETARIAT AND VERY SIGNIFICANT PROGRESS HAS BEEN ACHIEVED IN SOME OF THE PARTICIPATING COUNTRIES.

NEVERTHELESS, THE SLOW PACE OF IMPLEMENTATION AT THE REGIONAL LEVEL IS STILL A SOURCE OF CONCERN AS VERY LIMITED RESULTS CAN BE OBSERVED TO DATE.

THE DELAY IN THE PAYMENT OR LACK OF PAYMENT, OF NATIONAL CONTRIBUTIONS TO THE LAKE TANGANYIKA AUTHORITY STILL CONSTITUTES AN IMPORTANT CONSTRAINT TO THE IMPLEMENTATION OF THE PROJECT. IT IS ALSO A SOURCE OF CONCERN IN RELATION TO THE SUSTAINABILITY OF THE LTA.

ALSO, ALLOW ME TO REMIND YOU THAT THESE NATIONAL CONTRIBUTIONS ARE EXPECTED TO BE PAID AS COUNTERPART FUNDS FOR EACH OF THE FOUR PRODAP LOANS TO ALLOW FOR THE PAYMENT OF NCU STAFF SALARIES AND SOME OPERATING COSTS.

TWO YEARS AFTER THE CREATION OF THE LAKE TANGANYIKA AUTHORITY, IT MIGHT BE NECESSARY TO REEVALUATE THE TERMS AND CONDITIONS OF THE CONTRIBUTIONS OF THE RIVERINE COUNTRIES TO THE LTA, TO ENSURE THAT THEY CAN BE COMPLIED WITH ON A SUSTAINABLE BASIS.

ALLOW ME TO REMIND YOU, THAT THE CURRENT DATE OF LAST DISBURSEMENT FOR PRODAP IS SET AT 31 JANUARY 2012. THEREFORE, IN PRINCIPLE WE HAVE HARDLY MORE THAN ONE YEAR LEFT TO CONCLUDE THE PROJECT ACTIVITIES.

HONOURABLE MINISTERS, MORE THAN EVER WE RELY ON YOUR SUPPORT TO ACCELERATE THE IMPLEMENTATION OF THE PROJECT TO SUPPORT THE LAKE TANGANYIKA INTEGRATED REGIONAL DEVELOPMENT PROGRAMME AND ACHIEVE ITS OBJECTIVES FOR THE SUSTAINABLE USE OF THE LAKE TANGANYIKA BASIN NATURAL RESOURCES AND THE IMPROVEMENT OF THE LIVING CONDITIONS OF THE RIVERINE POPULATIONS.

LADIES AND GENTLEMEN

AS A COUNTRY DIRECTOR OF THE UNDP ZAMBIA, I WISH TO JOIN THE DISTINGUISHED REPRESENTATIVES IN WELCOMING THE DELEGATES TO THIS 4TH CONFERENCE OF MINISTERS. IN THE SAME VEIN, LET ME THANK THE ZAMBIAN GOVERNMENT FOR THE INVITATION EXTENDED TO UNDP AND FOR HOSTING THIS IMPORTANT CONFERENCE. THIS GESTURE REAFFIRMS THE COMMITMENT OF THE GOVERNMENT OF THE REPUBLIC OF ZAMBIA IN FURTHERING THE SUSTAINABLE MANAGEMENT OF LAKE TANGANYIKA. I WOULD LIKE TO EMPHASIZE THAT WE RECOGNIZE THE ROLE OF THE CONFERENCE OF MINISTERS, WHICH HAS COME HERE TODAY TO ENSURE THE EFFICIENT AND EFFECTIVE IMPLEMENTATION OF THE CONVENTION ON THE SUSTAINABLE MANAGEMENT OF THE LAKE TANGANYIKA.

I WOULD LIKE TO UNDERLINE THE IMPORTANCE OF THE LAKE TANGANYIKA AUTHORITY IN COORDINATING EFFORTS TO IMPLEMENT THE REGIONAL INTEGRATED MANAGEMENT AND DEVELOPMENT PROGRAMME. THAT PROGRAMME INCLUDES BOTH NATIONAL AND REGIONAL COMPONENT AND JOINTLY IMPLEMENTED BY UNDP AND GLOBAL ENVIRONMENT FACILITY PROJECT. BOTH AS WELL AS PARTNERS THEY HAVE BEEN NAMED HERE ADB, FAO, UNEP AMONG OTHERS, REMAIN COMMITTED TO THE CONSERVATION OF BIODIVERSITY AND MANAGEMENT OF NATURAL RESOURCES IN THE LAKE TANGANYIKA BASIN

IMPROVING THE LIVELIHOODS OF PEOPLE LIVING IN THE LAKE BASIN THROUGH THE USE OF SUSTAINABLE DEVELOPMENT STRATEGIES IS A GOAL THAT THE UNDP STRONGLY ADVOCATES AND ADVOCATES IN ALL THE COUNTRIES IN WHICH THAT ARE REPRESENTED HERE. OUR HUMAN DEVELOPMENT PARADIGM PLACES PEOPLE AT THE CENTER OF DEVELOPMENT ENDEAVORS AND WHICH BIODIVERSITY OF LAKE TANGANYIKA WHICH HARVESTS THE SECOND LARGEST IN LAND FISHES IN AFRICA AND IT'S A HOME TO MILLIONS OF PEOPLE WE KNOW IS UNDER THREAT.

HONORABLE MINISTER, THE RICH BIODIVERSITY AND DEVELOPMENT NEEDS IN THE LAKE TANGANYIKA BASIN ARE AMONG MANY REASONS WHY UNDP AND THE GLOBAL ENVIRONMENT FACILITY HAS BEEN PROVIDING TECHNICAL SUPPORT FOR A PERIOD OF ALMOST TWO DECADES, WE ARE PROUD TO HAVE BEEN AMONG THE COOPERATIVE PARTNERS THAT SUPPORTED A NUMBER OF KEY INITIATIVES WHICH HAVE PAVED A WAY TO CURRENT FRUITFUL COOPERATION AND TO NAME A FEW, THE STRATEGIC ACTION PROGRAMME FOR LAKE TANGANYIKA, THE FORMULATION OF THE LAKE TANGANYIKA CONVENTION, THE ESTABLISHMENT OF THE LAKE TANGANYIKA AUTHORITY, AND MOST RECENTLY, THE FORMULATION OF THE INTEGRATED MANAGEMENT AND DEVELOPMENT PROGRAMME.

WE BELIEVE THAT WITH THESE INTERVENTIONS A STRONG AND SUSTAINABLE FOUNDATION HAS BEEN BUILT FOR FURTHER ACTIVE COOPERATION AMONG THE RIPARIAN COUNTRIES, STAKEHOLDERS AND COOPERATING PARTNERS. IT IS ONLY THROUGH SUCH EFFORTS THAT WE CAN ESTABLISH A TRULY INTEGRATED SUSTAINABLE MANAGEMENT OF NATURAL RESOURCES AND AT THE SAME TIME IMPROVE THE LIVING CONDITIONS OF THE PEOPLE IN THE LAKE TANGANYIKA BASIN.

HONORABLE MINISTER, WITH THESE REMARKS, LET ME THANK THE SECRETARIAT OF THE LAKE TANGANYIKA AUTHORITY FOR THEIR ROLE IN ORGANIZING THIS CONFERENCE. LASTLY, I WISH THE CONFERENCE FRUITFUL DELIBERATIONS.

LADIES AND GENTLEMEN

IT IS FOR ME A GREAT PLEASURE AND A PRIVILEGE TO ADDRESS THIS MEETING ON BEHALF OF THE DIRECTOR GENERAL OF THE FOOD AND AGRICULTURE ORGANIZATION OF THE UNITED NATIONS (FAO), MR. JACQUES AND MR. ANIMATISME, ASSISTANT DIRECTOR GENERAL OF THE FISHERIES AND AGRICULTURE DEPARTMENT. LAKE TANGANYIKA HOSTS ONE OF THE LARGEST INLAND FISHERIES IN AFRICA. THE ANNUAL LANDINGS UP TO 200,000 TONS VALUED AT 100 MILLION USD AND FISH IS TRADED FAR BEYOND BORDERS OF THE FOUR RIPARIAN COUNTRIES. THE LAKE IS THEREFORE AN ENORMOUSLY IMPORTANT SOURCE OF FOOD, INCOME AND LIVELIHOODS FOR MILLIONS OF PEOPLE NOT ONLY IN THE FOUR COUNTRIES THAT SHARE THE LAKE BUT IN THE ENTIRE EAST AFRICAN REGION.

LET US RECALL FOR THE MOMENT THE HISTORY OF COLLABORATION BETWEEN THE FOUR COUNTRIES BORDERING LAKE TANGANYIKA AND FAO. IT GOES BACK AT LEAST 40 YEARS TO THE EARLY 1970'S WHEN SEVERAL FISHERIES PROJECTS WERE IMPLEMENTED. THEN IN 1977, THE FOUR COUNTRIES REQUESTED FAO'S COMMITTEE FOR INLAND FISHERIES OF AFRICA (CIFA) TO CREATE A SUB-COMMITTEE FOR DEVELOPMENT AND MANAGEMENT OF THE FISHERIES OF LAKE TANGANYIKA. LATER THIS BODY WAS REQUESTED TO FORMULATE AND PREFUNDING 4 REGIONAL RESEARCH PROJECTS ON THE LAKE.

THE FINNISH INTERNATIONAL DEVELOPMENT AGENCY (FINNIDA) EVENTUALLY HONORED THE REQUEST FOR SUPPORT OF THE 4 COUNTRIES AND THEN FAO EXECUTED REGIONAL RESEARCH PROJECT OF 5 YEARS DURATION ENTITLED RESEARCH FOR THE MANAGEMENT OF THE FISHERIES ON LAKE TANGANYIKA, BECAME OPERATIONAL IN 1992 AND CONTINUED UNTIL 2001. THE PROJECT RESULTED IN THE DEVELOPMENT OF THE LAKE TANGANYIKA FRAMEWORK FISHERIES MANAGEMENT PLAN (FFMP) WHICH WAS ADOPTED BY THE FOUR COUNTRIES AND THE SUB-COMMITTEE FOR LAKE TANGANYIKA. SUBSEQUENTLY THE CONVENTION ON SUSTAINABLE MANAGEMENT OF LAKE TANGANYIKA WAS SIGNED IN 2003 AND ENTERED INTO FORCE IN 2008, PROVIDING THE LEGAL FRAMEWORK OF THE ESTABLISHMENT OF THE LAKE TANGANYIKA AUTHORITY AND THE IMPLEMENTATION OF THE LAKE TANGANYIKA INTEGRATED REGIONAL AND DEVELOPMENT PROGRAMME.

IT IS UNDER THIS PROGRAMME THAT FAO WILL PROVIDE TECHNICAL ASSISTANCE ON SUSTAINABLE FISHERIES MANAGEMENT. FAO IS READY AND LOOKS FORWARD TO START WORKING WITH THE LTA ON THE IMPLEMENTATION OF THE PROGRAMME. AND WE ARE CONFIDENT THAT THE OBJECTIVES WILL BE REACHED IN A TIMELY MANNER. MUCH HAS THEREFORE BEEN ACHIEVED SINCE THE COLLABORATION STARTED WITH THE SUBCOMMITTEE FOR THE DEVELOPMENT AND MANAGEMENT OF THE FISHERIES OF LAKE TANGANYIKA.

HOWEVER, THE ISSUES ARE STILL RELEVANT. PART WITH THE ESTABLISHMENT OF THE LAKE TANGANYIKA AUTHORITY, YOU THE 4 COUNTRIES HAVE TAKEN THE MATTER INTO YOUR OWN HANDS. THIS IS A SUCCESS STORY WHICH WILL STAND AS AN EXAMPLE FOR OTHERS TO FOLLOW. SIGNIFICANT CHALLENGES MUST STILL BE FACED. INITIALLY, IT WAS MOSTLY A QUESTION OF DEVELOPING THE FISHERIES OF THE LAKE IN ORDER TO MAXIMIZE BENEFIT AND FEED THE POPULATIONS AROUND IT. THE FOCUS IS NOW ON SUSTAINING THE FISHERIES AND WITH THE NEW PRESSURES PUT ON FISHERIES DUE TO CLIMATE CHANGE AND EXCESSIVE FISHING EFFORTS, MANAGEMENT APPROACHES WILL NEED TO FOLLOW AN EVEN MORE PRECAUTIONALLY PATH.

WE ALL KNOW THAT THE LTA IS VERY MUCH AWARE OR IS CONCERNED ABOUT CHALLENGES PRESENTED BY CLIMATE CHANGE TO THE FISHERIES SECTOR. IN APRIL OF THIS YEAR IN BUJUMBURA, LTA AND FAO WITH SUPPORT FROM JAPAN JOINTLY ORGANIZED A WORKSHOP ON CLIMATE CHANGE AND FISHERIES IN THE GREAT AFRICAN LAKES WITH PARTICIPANTS FROM 8 AFRICAN COUNTRIES. WE ARE EXTREMELY GRATEFUL FROM THE LTA AND IN PARTICULAR DR. MWIMA, MR. HAKIZIMANA AND MR. KATONDA FOR ENSURING A WELL ORGANIZED AND SUCCESSFUL MEETING. THE MEETING CLEARLY DEMONSTRATED THAT THERE IS A STRONG INTEREST AND SIGNIFICANT ANXIETY IN EAST AFRICAN REGION ABOUT THE POTENTIAL IMPACT OF CLIMATE CHANGE. HOWEVER, YOU CAN BE ENSURED THAT FAO IS PREPARED TO ASSIST THE REGION IN GATHERING AND ANALYZING THE NECESSARY INFORMATION IMPENDING RESILIENCE IN YOUR FISHING COMMUNITIES.

I WOULD LIKE TO CONCLUDE BY THANKING YOU FOR INVITING FAO TO ATTEND THE MEETING WHICH I AM CERTAIN WILL BE PRODUCTIVE. AND ONCE AGAIN, WE ARE LOOKING FORWARD TO CONTINUE COLLABORATION BETWEEN YOUR COUNTRIES AND THE LTA.

FIRST AND FOREMOST IUCN WOULD LIKE TO THANK THE ORGANIZERS OF THIS MEETING FOR THEIR EXPERTISE AND FOR THEIR FACILITATION OF OUR ATTENDANCE - ESPECIALLY THE LTA TEAM. WE APPRECIATE A FORUM SUCH AS THIS AS IT ENABLES THE SHARING AND DISCUSSIONS OF IDEAS WITH THOSE WITH WHOM WE SHARE OUR INTERESTS AND EXPERTISE AND ALSO PRESENTS OPPORTUNITIES TO PICK UP NEW IDEAS GEARED TOWARDS THE REALIZATION OF THE MAIN OBJECTIVE OF THE LAKE TANGANYIKA CONVENTION WHICH IS TO ENSURE "THE PROTECTION AND CONSERVATION OF THE BIOLOGICAL DIVERSITY AND THE SUSTAINABLE USE OF THE NATURAL RESOURCES OF LAKE TANGANYIKA AND ITS BASIN BY THE CONTRACTING STATES ON THE BASIS OF INTEGRATED AND CO-OPERATIVE MANAGEMENT.

IUCN ASSURES THE ASSEMBLED COMPANY OF ITS DEDICATION TO LESSENING THE THREAT OF BIOLOGICAL INVASIONS TO THE BIODIVERSITY OF LAKE TANGANYIKA AND ITS CATCHMENT. AS TIME GOES BY WE SEE MORE AND MORE ALIEN SPECIES SPREADING ACROSS CONTINENTAL AFRICA AND AFFECTING MANY ECOSYSTEMS AND SO AFFECTING MANY LIVELIHOODS AND PRODUCTION SYSTEMS.

IN THE COMING YEAR AND A HALF, IUCN WITH ITS MANY YEARS OF EXPERIENCE OF BIODIVERSITY AND NATURAL RESOURCE CONSERVATION AND MANAGEMENT, WILL BE FOCUSING ON THE MOST IMPORTANT INVASIVE ALIEN SPECIES IN THE PRECIOUS LAKE TANGANYIKA ECOSYSTEM, THEIR IMPACT, THEIR DISTRIBUTION AND POSSIBILITIES FOR THEIR MANAGEMENT THROUGH CAPACITY BUILDING AND RAISING OF AWARENESS. WE WOULD LIKE TO CALL FOR INTERACTION AND COOPERATION AMONG THE COMPONENTS OF THE BIGGER PROJECT AS WE AIM TO IMPROVE THE LIVING CONDITIONS OF THE RIPARIAN POPULATIONS THROUGH IMPLEMENTATION OF THE STRATEGIC ACTION PROGRAMME TOWARDS BRINGING ABOUT INTEGRATED SUSTAINABLE MANAGEMENT AND PROTECTION OF THE LAKE TANGANYIKA ECOSYSTEM. IUCN BELIEVES THAT THE FIVE COMPONENTS (LAND USE AND EROSION, FISHERIES, WATER QUALITY, AQUATIC BIODIVERSITY AND INVASIVE SPECIES MONITORING) WILL HAVE M.UCH INFORMATION TO SHARE AS WE FOCUS ON THE BIGGER PICTURE OF INTERVENTIONS TO PROTECT THIS GREAT LAKE. WE CAN DO MORE TOGETHER THAN SEPARATELY AND SO IUCN INTENDS TO WORK WITH THE FOUR NATIONAL PROGRAMMES AS WELL.

WE WOULD LIKE TO CALL UPON THE LOCAL COMMUNITIES OF THE LAKE AND CATCHMENT - (WHO ARE THE COAL-FACE STAKEHOLDERS HERE) - TO PARTICIPATE IN THE IMPLEMENTATION OF THE PROJECT SO THAT THERE IS SOME FORM OF SUSTAINABILITY AT THE END OF THIS PHASE OF IMPLEMENTING THE UPDATED SAP. WE ALSO HOPE TO BRING SOME LESSONS LEARNED FROM BOTH THE OTHER GREAT LAKES OF AFRICA - VICTORIA AND MALAWI, WHERE WE HAVE BEEN WORKING - TO ADD TO THE CONSERVATION-THROUGH-ACTION FOR TANGANYIKA'S ALL-IMPORTANT BIODIVERSITY.

IT IS A GREAT HONOUR FOR ME TO OFFICIATE AT THIS HIGH LEVEL SEGMENT TO MARK THE FOURTH SESSION OF THE CONFERENCE OF MINISTERS FOR THE LAKE TANGANYIKA AUTHORITY. MY GOVERNMENT ALSO FEELS HONOURED THAT PARTIES TO THE LAKE TANGANYIKA CONVENTION CHOSE ZAMBIA TO HOST THIS CONFERENCE.

ALLOW ME, THEREFORE, ON BEHALF OF THE ZAMBIAN GOVERNMENT, TO WELCOME YOU AND HOPE THAT YOU ENJOY THE WARM ZAMBIAN HOSPITALITY. I MUST STATE THAT HAVING TRAVELLED THIS FAR TO ATTEND AND CONTRIBUTE TO THIS CONFERENCE, DEMONSTRATES THE COMMITMENT THAT YOU ATTACH TO THE PROTECTION OF THE LAKE BASIN AS WELL AS IMPROVING THE LIVELIHOOD OF THE 10 MILLION PEOPLE THAT LIVE AND DEPEND ON THE LAKE.

ECONOMIC ACTIVITIES ON THE LAKE SUCH AS FISHING AND TRANSPORTATION HAVE ALSO INCREASED. MY GOVERNMENT ALSO WISHES TO ACKNOWLEDGE THE IMMENSE SUPPORT MEMBER STATES ARE RECEIVING FROM COOPERATING PARTNERS TOWARDS THE SUSTAINABLE MANAGEMENT OF LAKE TANGANYIKA AND POVERTY ALLEVIATION IN THE LAKE BASIN. I AM AWARE THAT OUR GOVERNMENTS ARE BEING SUPPORTED IN THE IMPLEMENTATION OF THE LAKE TANAGANYIKA INTEGRATED MANAGEMENT PROJECTS TO ADDRESS CONCERNS OF SEDIMENTATION, DEFORESTATION, OVER FISHING AND WATER POLLUTION TO MENTION BUT A FEW. DECLARATION OF THE LAKE TANGANYIKA CONFERENCE OF MINISTERS' FOURTH ORDINARY MEETING

We, the members of the Lake Tanganyika Conference of Ministers from the Republic of Burundi, the Democratic Republic of Congo, the United Republic of Tanzania and the Republic of Zambia,

Having met in Lusaka, Republic of Zambia on 26th November, 2010 at the fourth ordinary meeting of the Conference of Ministers,

Recognizing and appreciating the Conference's role in providing leadership in accordance with the Convention on the Sustainable Management of Lake Tanganyika signed by the Contracting States of the Republic of Burundi, the Democratic Republic of Congo, the United Republic of Tanzania and the Republic of Zambia on the 12th June, 2003 in Dar Es Salaam, the United Republic of Tanzania,

Expressing appreciation for the support provided by the African Development Bank, the United Nations Development Programme and Global Environment Facility, the Food and Agriculture Organization of the United Nations, the World Conservation Union and other partners, in supporting the Lake Tanganyika Integrated Regional Development and Management Programme with the aim of protecting the biodiversity and achieving sustainable management of the natural resources of Lake Tanganyika and its Basin,
